## Key Terms

### Services Provided:

Provider will deliver, set up, and remove the photo booth. Included items may include props, backdrop, and digital image delivery as agreed at booking. If an attendant is included in the selected package, Provider will operate the booth during the rental window.

### Client Responsibilities:

Client will provide a safe, level setup area and access to one standard power outlet within 10 feet of the booth location. Client is responsible for guest behavior and for any damage caused by guests, attendees, or venue staff.

### Cancellation & Rescheduling:

Cancellations within 14 days of the event forfeit all payments. Rescheduling is subject to availability and may require additional fees (for example, changes to travel, staffing, or timing).

### Equipment Damage & Early Termination:

Client is responsible for damage beyond normal wear and tear. Provider may end service early if equipment is at risk (for example: unsafe crowd behavior, water exposure, or venue restrictions).

### Force Majeure:

Provider is not liable for failure to perform due to circumstances beyond Provider's control (including severe weather, illness, venue access restrictions, or other events that make performance impracticable).

### Limitation of Liability:

Provider's total liability under this Agreement will not exceed the amount paid by Client for the rental.

### Governing Law:

This Agreement is governed by the laws of the State of Maine.
